## Public Hearing Scheduled for May 7, 2019

Lake County invites you to the public hearing regarding transportation improvements to Round Lake Road. The hearing is being held as an agenda item as part of the Lake County Board of County Commissioners meeting scheduled on **Tuesday, May 7, 2019** at the **Lake County Administration Building in the Board Chambers (2<sup>nd</sup> floor), located at 315 W. Main Street, Tavares, Florida 32778**. The County Commission meeting will begin at 10:00 a.m. with the Round Lake Road public hearing to be held after that time as determined by the Board meeting agenda. The hearing is being conducted to provide interested persons an opportunity to express their views concerning the social, economic, and environmental impacts of the proposed Round Lake Road improvements.

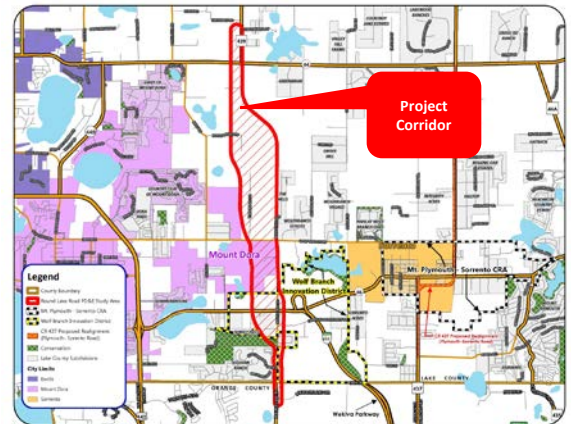

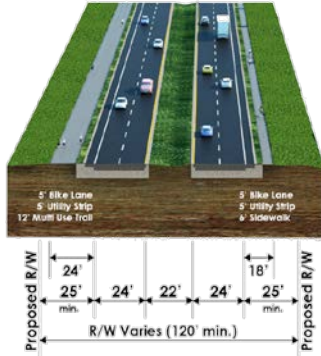

## Study Recommendations

As a result of the input we received and detailed technical evaluations, the study recommendation is to move forward with the Build Alternative. This alternative follows existing Round Lake Road, from the Orange/Lake County line to Wolf Branch Road and continues on a new alignment from Wolf Branch Road to north of State Road 44, as shown in the graphic to the right.

Features of the Recommended Alternative are shown in the typical section below. This study recommendation will be presented at the May 7<sup>th</sup> public hearing. (See front page for hearing information.)
